Restart plan for Rizzieri Aveda School, in accordance with Executive Order 155

a. Training for students regarding COVID-19 sanitization and social distancing practices and protocols as a condition for resuming in-person instruction;

Students will receive a training video prior to returning to the building. All students are required to complete the Barbicide Certification prior to returning to school.

b. Training for faculty and staff on appropriate sanitization and social distancing practices and protocols, as well as institutional policies and procedures developed to limit the spread of COVID-19;

Staff members will receive a training video prior to returning to the building to work. Our staff has also completed the Barbicide Certification course. We have an institutional policy/procedures in place to limit the spread of COVID-19, which will be reviewed with our staff and students prior to returning.

c. Use of face coverings for faculty, staff, students, and visitors, except when doing so would inhibit the individual's health;

The use of face coverings will be mandatory for all students and staff. Visitors would not be permitted since clinic/clients are prohibited at this time.

d. Frequent cleaning and sanitization of classrooms, restrooms, high-touch areas and equipment and shared surfaces;

We have engaged our cleaning company to perform extensive cleaning throughout the day, in addition to our nightly overall cleanings with a special emphasis on sterilization.

e. Maintenance of adequate supplies, such as personal protective equipment and cleaning supplies;

We will maintain a supply of masks and facial shields in the building as well as an abundance of cleaning supplies.

f. Installation of hand sanitizing stations with 60 percent or more alcohol content at all building

entry points and throughout the school;

Hand sanitizing stations containing over 60% alcohol will be set up throughout the building and at the entry points.

g. The option of remote instruction for faculty and students who are unable to participate in in-person instruction;

Our school will be utilizing distance, on ground, and/or a combination of both methods as some students will be continuing distance education, while others on a senior level will return to full in person instruction, in order to maintain social distancing.

h. Performance of health screenings for faculty, staff, students and visitors, and education regarding self-monitoring for symptoms;

Temperature checks will be performed on everyone prior to them entering the building. We will also be distributing a questionnaire to everyone upon arrival, which will include health screening questions.

i. Social distancing in classrooms, workstations, laboratories, clinical settings, and student seating areas throughout the training school and a plan for providing smaller class sizes if feasible;

By utilizing distance, on ground, and/or a combination of both methods of education, it will allow us to practice social distancing, as outlined in section 10 letter g. All classroom floors have been marked for social distancing purposes.

j. Plan for staggering start, break, and end times of class periods, or alternating scheduled class days to reduce crowding at the training school and classroom entryways;

Class start times are staggered, which allows us time for temperature scanning. Student break times will be staggered to reduce crowding. Some classes will alternate scheduled class days to reduce class size.

k. Commitment to working with local and State officials, including the local health department and local office of emergency management, to share the components of the restart plan and revise same as may be necessary; and

We have reached out to our local officials to develop a plan and we will share components of our restart plan with them.

l. Establishment of COVID-19 testing guidance and contact tracing protocols developed in consultation with local health officials and in line with existing State and federal health privacy statutes and regulations. At a minimum, such protocols should include a mechanism to maintain a log of students, faculty, staff, and visitors to facilitate contact tracing, and the reporting of any instances of COVID-19 to local health

officials.

Our system in place will maintain a log of information regarding those who have entered the building and we will report an instances of covid19 to our local health officials.
